

PRIVACY POLICY & STATEMENT

Privacy policy and data protection is very important to us. We shall use all our best efforts to ensure that your privacy is protected. In the course of you using our services, we may request you to provide us with certain information. We assure you that any information procured from you will only be used in accordance with this privacy statement.

Please take note that we may change this policy from time to time by updating this page without any notification to you. You should frequently check this page for any updates from time to time to ensure that you are happy with any changes.

1. What we collect

We may from time to time collect or request the following information from you:

- Name
- Postal address
- Email address
- Mobile number
- User process details (including but not limited to representatives of merchants, identification data of merchants, item or services purchased, country, date and time)
- Banking details
- Preferred language
- Preferred services or products
- Credit card or debit card information (including but not limited to card number, name on card, expiry date and CVC)
- Other information relevant to customer surveys and/or offers.

In addition to the foregoing, we may further collect the following information provided by you in the following circumstances:

- If and when you create an account with BOLD.Pay, then your username, password, date of birth, gender, mobile number and such other information requested by us, and filled in by you, may be collected.
- If and when you sell goods or services and entered the order in BOLD.Pay merchant portal, then what you sell, where you sell to, who you sell to, the frequency of your sales, may be collected.

2. What we do with the information

- to enable us process or supply the services you have requested
- to enable us to you accordingly whether to your network operator, credit card, debit card or otherwise.
- to enable us to trace your information based on the information provided
- to analyze and improve, and develop our products and services.
- We may contact you from time to time based on the information provided by you for research purposes.
- We may use your information for survey or marketing, promotion purposes.
- For the purposes of internal track and record on your purchase information and details.
- To respond to your enquiries or feedbacks, and to take such actions in response to your enquiries and feedbacks.
- To communicate with you on any matters relating to BOLD.Pay, including but not limited to your sales, account, and such other news and updates pursuant to BOLD.Pay.
- The data that we collect from you may be transferred to, and stored at, a destination outside Malaysia. By submitting your information and accessing the Sites, you consent and agree to such transfers.

3. Security

We shall use our best efforts to ensure your information is secure. In order to prevent unauthorised access or disclosure, we have put in place what we deemed suitable physical, electronic and managerial procedures to safeguard

and secure the information we collect from you online. In addition, we ensure that only authorized employees, agents and contractors (who have agreed to keep information secure and confidential) of have access of your information on a strictly need to know basis only. Your information will be retained by us for a reasonable period as or as long as the law permits/requires.

4. What & how we use cookies

Overall, cookies help us provide you with a better website, by enabling us to monitor which pages you find useful and which you do not. A cookie in no way gives us access to your computer or any information about you, other than the data you choose to share with us.
